Each player must submit entry form with waiver and appropriate fees: \$20 for first event, \$5 for each additional event, less \$5 USAPA member discount.

Fees & waiver must be received within 7 days of online registration. No refunds after November 23 unless an event is cancelled.

Teams must play at the skill level of the highest rated partner. Unrated players may self-rate or can contact the Tournament Director for assistance. Rated players may not play below their USAPA rating. Participants may play in only one skill level bracket per event (max of 3 events).
